Since founding PA in 1985, Scott built the firm to be one of Australia's most respected quantity surveying firms specialising in the detailed measurement of complex projects.

PA employed up to 28 people and specialised in the following two areas:

- Builder's Bills of Quantities, and
- Expert witness and litigation support.

Builder's Bills of Quantities – PA provides detailed measurement of complex projects to builders who rely on the firm's accuracy to price and construct projects. Builder's Bills of Quantities are required to be more detailed and accurate than Client's Bills of Quantities, which are able to contain inaccuracies and may be adjusted.

Over the last 15 years, PA has produced over 1,400 Builder's Bills of Quantities with a construction value in excess of \$20 billion (constant \$).

Recent key projects include:

- Dr Chau Chak Wing Building at the University of Technology, Sydney as designed by Frank Gehry (\$120 million construction cost);
- Chris O'Brien's Life House at Royal Prince Alfred Hospital (\$150 million construction cost);
- the new Royal Adelaide Hospital (\$1,400 million construction cost). Scott priced the Cost Plan 3 for this project; and
- HNA Defence Project in Adelaide (\$400 million construction cost).

As managing director, Scott's role included the supervision of measurement, detailed measurement of complex aspects of the construction projects and preparation of cost plans. A list of the types of projects measured by PA is set out in Annexure 1 as at Scott's retirement in 2013.

Expert witness and litigation support – Scott regularly acted as an expert witness and provided litigation support for disputes involving commercial, civil and residential construction projects. In the last 33 years, Scott has appeared as an expert witness and/or provided expert reports in over 180 construction disputes. Scott's work as an expert involves the preparation, assessment and quantification of claims.

SPECIFIC RELEVANT EXPERIENCE ON NSW PUBLIC SCHOOLS

Public and High Schools

Between 1996 and 2009, PA prepared detailed Bills of Quantities for some 55 NSW public and high schools for building contractors to prepare tenders, including Glenmore Public, Nirimba Public, Lake Munmorah High, Dubbo High, Wadalba High Stage 2, Chifley Senior Campus, Great Lakes Joint Education Campus, Mt Annan High, Kellyville High, Avoca Public, Anna Bay Public, Bermagui Public, Canley Vale Public and Banora Point Public.

PA had a detailed knowledge of the NSW Public Works standard designs for public schools, including the Schools Facilities Standard, Specifications and detailed drawings.

BER Schools

Scott's initial involvement in the BER schools' project, was when the IPO issued the seven standard drawings to the Managing Contractors who were tendering for the 13 NSW regions. PA measured the Bills of Quantities for the initial seven standard buildings and further buildings as were issued to all the Managing Contractor tenderers.

At a subsequent meeting at the IPO I meet Mr Vince Shaw and he advised me that the standardisation of the Bill of Quantities for the buildings was a great benefit to the IPO.

PA also measured BER Schools in Victoria and Queensland for various builders.

Illawarra Region and South East Region
