# 1. POLICY STATEMENT

The Australian Institute of Quantity Surveyors (AIQS), and related bodies corporate (we, our, us) are committed to protecting the privacy and security of your personal information This document is our privacy policy and it tells you how we collect and manage your personal information in accordance with the Australian Privacy Act 1988 (Cth).

#### 1.1 What is Your Personal Information?

When used in this privacy policy, the term "personal information" has the meaning given to it in the Australian Privacy Act 1988 (Cth). In general terms, it is any information that can be used to personally identify you. If the information we collect personally identifies you, or you are reasonably identifiable from it, the information will be considered personal information.

#### 1.2 What Personal Information Do We Collect and Hold?

We may collect the following types of personal information:

- Personal details
  - o age
  - o birth date
  - o gender
- Contact details
  - o name
  - o mailing/shipping address
  - o personal street address
  - o employer street address
  - o email address
  - o telephone number
- Professional details
  - o curriculum vitae (CV)
  - o references
  - o occupation
  - o job titles
  - o current employers
  - o previous employers
  - o association memberships
  - o government authority registration

- Criminal details
- Education details
  - o qualification and completion date
  - o institutions
- Financial activity
  - o purchase of products/services
- Contact history
  - any email/webform sent by you/your legal representative
  - o survey responses

#### 1.3 How Do We Collect Your Personal Information?

We collect your personal information directly from you or your authorised representative(s) unless it is unreasonable or impracticable to do so. When collecting personal information from you, we may collect in ways including:

- through your or your authorised representative(s) access and use of our websites;
- during conversations between you or your authorised representative(s) and our representatives; or
- when you or your authorised representative(s) complete an application or purchase order.

We may also collect personal information from third parties including:

• from third party companies such as credit reporting agencies, law enforcement agencies and other government entities.

# 1.4 Cookies

In some cases, we may also collect your personal information through the use of cookies. When you access our website, we may send a "cookie" (which is a small summary file containing a unique ID number) to your computer. This enables us to recognise your computer and greet you each time you visit our website without bothering you with a request to register. It also enables us to keep track of products or services you view so that, if you consent, we can send you news about those products or services.

We also use cookies to measure traffic patterns, to determine which areas of our website have been visited and to measure transaction patterns in the aggregate. We use this to research our users' habits so that we can improve our online products and services.

Our cookies do not collect personal information. If you do not wish to receive cookies, you can set your browser so that your computer does not accept them.

We may log IP addresses (that is, the electronic addresses of computers connected to the internet) to analyse trends, administer the website, track users' movements, and gather broad demographic information.

#### 1.5 What Happens if We Can't Collect Your Personal Information?

If you do not provide us with the personal information described above, some or all of the following may happen:

- we may not be able to provide the requested products or services to you, either to the same standard or at all;
- we may not be able to provide you with information about products and services that you may want, including information about discounts, sales or special promotions; or
- we may be unable to tailor the content of our websites to your preferences and your experience of our websites may not be as enjoyable or useful.

# 1.6 For What Purposes Do We Collect, Hold, Use and Disclose Your Personal Information?

We collect personal information about you so that we can perform our business activities and functions and to provide best possible quality of customer service.

We collect, hold, use and disclose your personal information for the following purposes:

- to provide products and services to you and to send communications requested by you;
- to answer enquiries and provide information or advice about existing and new products or services;
- to provide you with access to protected areas of our website;
- to assess the performance of the website and to improve the operation of the website;
- to conduct business processing functions including providing personal information to our related bodies corporate, contractors, service providers or other third parties;
- for the administrative, marketing (including direct marketing), planning, product or service development, quality control and research purposes of The Australian Institute of Quantity Surveyors, its related bodies corporate, contractors or service providers;
- to provide your updated personal information to our related bodies corporate, contractors or service providers;
- to update our records and keep your contact details up to date;
- to process and respond to any complaint made by you; and
- to comply with any law, rule, regulation, lawful and binding determination, decision or direction of a regulator, or in co-operation with any governmental authority of any country (or political sub-division of a country).
- Your personal information will not be shared, sold, rented or disclosed other than as described in this Privacy Policy.

#### 1.7 To Whom May We Disclose Your Information?

We may disclose your personal information to:

- our employees, related bodies corporate, contractors or service providers for the purposes of operation of
  our website or our business, fulfilling requests by you, and to otherwise provide products and services to you
  including, without limitation, web hosting providers, IT systems administrators, mailing houses, couriers,
  payment processors, data entry service providers, electronic network administrators, debt collectors, and
  professional advisors such as accountants, solicitors, business advisors and consultants;
- authorised representative(s) as nominated by yourself;

- suppliers and other third parties with whom we have commercial relationships, for business, marketing, and related purposes; and
- any organisation for any authorised purpose with your express consent.

We may combine or share any information that we collect from you with information collected by any of our related bodies corporate (within Australia).

# 1.8 Direct Marketing Materials

We may send you direct marketing communications and information about our products and services that we consider may be of interest to you. These communications may be sent in various forms, including mail, SMS, and email, in accordance with applicable marketing laws, such as the Spam Act 2003 (Cth). If you indicate a preference for a method of communication, we will endeavour to use that method whenever practical to do so. In addition, at any time you may opt- out of receiving marketing communications from us by contacting us (see the details below) or by using opt-out facilities provided in the marketing communications and we will then ensure that your name is removed from our mailing list.

We do not provide your personal information to other organisations for the purposes of direct marketing.

#### 1.9 How Can You Access and Correct Your Personal Information?

You may request access to any personal information we hold about you at any time by contacting us (see the details below). Where we hold information that you are entitled to access, we will try to provide you with suitable means of accessing it (for example, by mailing or emailing it to you). We may charge you a fee to cover our administrative and other reasonable costs in providing the information to you. We will not charge for simply making the request and will not charge for making any corrections to your personal information.

There may be instances where we cannot grant you access to the personal information we hold. For example, we may need to refuse access if granting access would interfere with the privacy of others or if it would result in a breach of confidentiality. If that happens, we will give you written reasons for any refusal.

If you believe that personal information we hold about you is incorrect, incomplete or inaccurate, then you may request us to amend it. We will consider if the information requires amendment. If we do not agree that there are grounds for amendment, then we will add a note to the personal information stating that you disagree with it.

#### 1.10 What is the Process for Complaining About a Breach of Privacy?

We endeavour to respond to complaints and queries within fourteen days of receipt. If you are dissatisfied with our response, you may refer the matter to the Australian Information (Privacy) Commissioner.

#### 1.11 Do We Disclose Your Personal Information to Anyone Outside Australia?

We may disclose personal information to our related bodies corporate and third-party suppliers and service providers located overseas for some of the purposes listed above.

We take reasonable steps to ensure that the overseas recipients of your personal information do not breach the privacy obligations relating to your personal information.

We may disclose your personal information to entities located outside of Australia, including the following:

#### 1.12 Security

- our related bodies corporate, located in the Middle East
- our data hosting and other IT service providers

We take reasonable steps to ensure your personal information is protected from misuse and loss and from unauthorised access, modification or disclosure. We may hold your information in either electronic or hard copy form. Personal information is destroyed or de-identified when no longer needed.

As our website is linked to the internet, and the internet is inherently insecure, we cannot provide any assurance regarding the security of transmission of information you communicate to us online. We also cannot guarantee that the information you supply will not be intercepted while being transmitted over the internet. Accordingly, any personal information or other information which you transmit to us online is transmitted at your own risk.

#### 1.13 Links

Our website may contain links to other websites operated by third parties. We make no representations or warranties in relation to the privacy practices of any third-party website and we are not responsible for the privacy policies or the content of any third-party website. Third party websites are responsible for informing you about their own privacy practices.

# 1.14 Contacting Us
