

CEO'S REPORT

AIQS's role is to raise the profile of the broader quantity surveying profession through the development and dissemination of standards (educational, professional, and technical), the delivery of new information, and professional development.


2018-19 was the penultimate year in the current strategic planning cycle for AIQS. Significant shortcomings continued to be realised across the construction sector, resulting in state and territory governments moving to improve quality and confidence in the construction industry. AIQS actively provided input to address these issues at ministerial level through the Building Ministers' Forum, at government industry forums and through ACIF and the APCC. These interactions assist to raise the profile of the quantity surveying profession. While a number of governments have instigated reforms and increased regulation for the construction sector, we will need to wait to see if these actually provide improved outcomes for consumers.

Perhaps the most significant achievement during the year was hosting the joint International Cost Engineering Council – Pacific Association of Quantity Surveyors Conference held at the International Convention Centre, Sydney in November 2018 with 476 delegates from 29 countries and 72 speakers. Other important achievements throughout the year included the launch of the Australia and New Zealand BIM Best Practice Guide, the Construction Finance Reports Guidance Note and a Replacement Cost Assessments Information Paper. It was encouraging to see increased participation from members, government, finance, industry associations, and other representatives from the construction sector attend the AIQS executive forums.

Increased engagement with the construction and infrastructure sectors commenced during the year with a view to improving the AIQS value proposition for professionals in those sectors.

As in previous years, acknowledgment must be given to the head office staff for their dedication and professionalism in embracing change and pro-actively identifying and delivering initiatives for the benefit of members and the profession. In addition, I commend the commitment and dedication provided by the large number of members who have volunteered their time and expertise over the year in contributing to the AIQS Board, Chapter Councils, and Committees.

A new five year strategic plan will be implemented from 1 July 2020 ushering in new and dynamic initiatives. Further engagement across all levels of government is required in order to ensure the role and function of quantity surveyors are appropriately positioned. One thing is for sure, there will be further changes and enhancements for the profession.

AIQS 2015-20 STRATEGIC GOAL 1 GLOBALLY RECOGNISED BRAND

CONTINUED COLLABORATION WITH INTERNATIONAL ASSOCIATIONS

At the ICEC-PAQS 2018 Conference, Mutual Recognition Agreements (MRA) were signed with Hong Kong Institute of Surveyors, Singapore Institute of Surveyors and Valuers, Royal Institution of Surveyors Malaysia, and the Philippine Institute of Certified Quantity Surveyors. These agreements are designed to facilitate greater transportability of quantity surveying professionals between countries which typically have differing regulatory regimes. In addition, a Memorandum of Understanding (MOU) was signed with Indonesian Association of Quantity Surveyors. MOUs enable participating organisations to work together to increase professional, technical and education standards, and share information, and are typically forerunners to MRAs.

AIQS hosted the 3rd International QS BIM Conference as part of the ICEC-PAQS Conference in November 2018. Other participating organisations included Singapore Institute of Surveyors and Valuers, Royal Institution of Surveyors Malaysia, and the Hong Kong Institute of Surveyors.

SPREADING OUR BRAND GLOBALLY

AIQS increased brand recognition across Australia and globally through a robust presence on social media (LinkedIn, Twitter and Facebook). This has resulted in an increase of professionals working in various countries applying for membership with AIQS. AIQS reached out to suppliers around the world with regards to AIQS sponsorship and advertising opportunities.

AIQS 2015-20 STRATEGIC GOALS 2 + 3 CREDENTIAL OF CHOICE FOR CLIENTS AND MUST HAVE MEMBERSHIP

During 2018-19 we welcomed 222 new members into AIQS.

OUR MEMBER RETENTION RATE IS HIGH

AIQS has a retention rate of over 94% and we are seeing renewed growth in membership from the traditional consultancy base, as well as from the contractor sector.

INCREASED TAKE UP OF CQS DESIGNATION

Continued promotion of Certified Quantity Surveyor (CQS) has resulted in an increase in the number of corporate members taking up this designation. By 30 June 2019, 401 AIQS members had been rewarded with the CQS designation. All eligible corporate members are encouraged to take up the Certified Quantity Surveyor (CQS) designation as a mark of increased professionalism. Continued engagement with Commonwealth, State and Territory Government Agencies have highlighted the importance of engaging a Certified Quantity Surveyor from the inception of construction projects. This has resulted in an increasing number of government departments/agencies, local councils and financial institutions stipulating a requirement for CQS. Details of the

COMMENCEMENT OF GRADUATE MEMBERSHIP GRADE

Graduate membership grade enables recognition of professionals who have graduated from an AIQS recognised university degree but don't have the prerequisites to receive Member grade.

AIQS 2015-20 STRATEGIC GOAL 4 LEADING EDGE EDUCATION AND PROFESSIONAL DEVELOPMENT

ONLINE TRAINING

The AIQS Academy continues to attract large numbers of participants with an additional 800 individual modules being completed during the 2018-19 year.

FACE-TO-FACE EVENTS AND WEBINARS

AIQS delivered a total of 101 hours of CPD events and 25 networking events across the Chapters. Along with site visits, topics covered at these events and webinars included delay analysis, contract documentation and innovative procurement, tax depreciation, project bank accounts, data analytics, litigation and dispute management, BIM, quantitative risk analysis, disruption costs, personal brand development, construction financing reports, overcoming adversity, and design cost advice.

INSPIRING THE FUTURE WORKFORCE

AIQS continued to participate at Career Expos in all state and territory capital cities as well as Career Advisors Forums in Sydney and Hobart. These events enable AIQS to promote the built environment cost profession to high school students and career advisers as a rewarding career option.

ENGAGEMENT WITH UNIVERSITIES

As with previous years, AIQS sponsored 12 university awards across eight universities. AIQS actively engaged with accredited universities to promote the profession by providing leading sessional lectures, publications and presenting to encourage AIQS membership.

EDUCATION COMMITTEE

During 2018-19, the Education Committee recommended the continuation of all existing accredited university degrees which was Board approved.

YOUNG QUANTITY SURVEYORS PROGRAM

As well as organising well attended YQS events, AIQS YQS sub-committee members successfully delivered the Young Quantity Surveyors/Cost Engineers Program as a part of the ICEC-PAQS 2018 Conference.

AIQS 2015-20 STRATEGIC GOAL 5 RESPECTED THOUGHT LEADER AND ADVOCATE

PRO-ACTIVELY RAISING INDUSTRY ENGAGEMENT

Building on the initiatives implemented over previous years, 2018-19 saw a continuation of a more proactive approach to delivering member services and raising the profile of the built environment cost professions. Central to this has been continued engagement with a variety of stakeholders across the construction industry.

Once again, change has been the key, with a focus on building a dynamic professional institute at the forefront of the construction cost industry. AIQS executive lunches continue to be successful forums for engaging with the broader construction sector. Five forums were held around Australia with 113 attendees during 2018-19.

NEW COMMITTEES ESTABLISHED

2018-19 saw the establishment of two new committees - AIQS Diversity and Inclusion Committee and AIQS Infrastructure Committee.

The AIQS Diversity and Inclusion Committee is responsible for developing strategies to encourage deeper levels of diversity and inclusion amongst the membership base and within the built environment cost professions. Several initiatives were set in motion, including the establishment of a mentoring program named AIQS Advance, a scholarship targeted at female graduates, a nationwide roadshow focusing on diversity and inclusion within the workplace and guidelines around a more flexible workplace.

The AIQS Infrastructure Committee is responsible for the development and implementation of all infrastructure policy matters (protocols, standards, guidance, and/or risk profiles) on behalf of the Institute. Historically, built environment cost professionals have provided services on building projects. This Committee is in response to the growing number of built environment cost professionals who are providing a range of services on oil and gas, mining, utilities and transport projects.

GUIDANCE NOTES AND PUBLICATIONS

In November 2018, AIQS launched the Australia and New Zealand BIM Best Practice Guidelines in partnership with New Zealand Institute of Quantity Surveyors. These Guidelines are an essential guide for built environment cost professionals looking to be involved with a project utilising BIM.

AIQS Construction Finance Reports Guidance Note, developed in consultation with representation from financial institutions, was also launched in November 2018. The purpose of this Guidance Note is to create a uniform scope of service and clarify the quantity surveyor's role in providing construction cost management services to both the financier(s) and developer.



In June 2019, AIQS released the Replacement Cost Assessments Information Paper. The purpose of this Information Paper is to inform AIQS Members and their clients on factors impacting replacement cost assessments, and to establish a common approach to undertaking replacement cost assessments.

AIQS ENGAGES INDUSTRY AND GOVERNMENT

AIQS participated in high-level advocacy meetings with a commonwealth, state and territory government ministers and shadow ministers as arranged by ACIF (Australian Construction Industry Forum) of which AIQS is a member. AIQS regularly engages with the public and private sectors to promote the profession as well as the benefits of engaging a Certified Quantity Surveyor and over 2018-19 this included:

- AIQS is a member of the APCC procurement working group which is looking at how government construction procurement impacts the construction industry.
- Chilean Chamber of Commerce organised a meeting with AIQS as they are looking to the establish the quantity surveying profession in Chile.
- AIQS worked with Australasian BIM Advisory Board to increase the uptake of BIM within Government.
- AIQS assisted the Australian Taxation Office to review the effective life of assets for residential premises.
- AIQS attended the Building Ministers' Forum in Hobart in February 2019 to discuss the recommendations outlined in the Shergold and Weir Report.
- The AIQS BIM sub committee discussed reverse factoring with financial institutions.
- AIQS met with the New South Wales Government in relation to quantity surveyors preparing cost reviews for infrastructure projects.
- Participated on, and working with, the Tax Practitioners Board (TPB) to revise the governance structure ensuring that AIQS members, who are registered Tax Practitioners, comply with provisions of the Tax Agents Act.
- Western Australian Government - Department of Building and Major Works.
- Northern Territory Government - Department of Infrastructure, Planning and Logistics.
- Victorian Government - Department of Economic Development, Jobs, Transport and Resources.
- Queensland Government - State Development, Manufacturing, Infrastructure and Planning.

STRATEGIC GOAL 6 STRONG ORGANISATIONAL STRUCTURE AND COMMUNICATIONS

STRONG ENGAGEMENT WITH MEMBERS

Members benefited from concise and relevant communications via fortnightly e-Bulletins, the quarterly publication The Building Economist, and social media. Topics included technology, innovation, diversity, inclusion, agility, case studies, cost delay, disruption, efficiency, project controls, infrastructure, collaboration, standards, and sustainability.



NEW CRM SYSTEM , CORPORATE WEBSITE AND SOCIAL MEDIA

AIQS is working with a vendor to develop a customer relationship management platform and corporate website to enable the provision of increased services and information to members and users of member services on a more effective basis. The platform will be officially launched in 2020. Presence on social media was strengthened throughout the year, focusing on LinkedIn, Twitter and Facebook. LinkedIn is proving to be a standout as it draws in new membership, event attendees and CQS applicants.

STRATEGIC GOAL 7 DIVERSE AND SUSTAINABLE FUNDING

TREASURER'S REPORT

AIQS's financial performance continues to improve. For the very first time, AIQS had a turnover of \$3m. This was mainly in part due to the income from the hugely successful ICEC-PAQS Conference held in Sydney in November 2018. The AIQS Academy has also performed very well over the last 12 months with the capital investment by the AIQS expected to be returned now at least 12 months ahead of the timeline indicated in the business case presented to the Board back in 2015. Once again, income from Skilled Migration Assessments continues to be a 'windfall' for AIQS due to the heightened state of the construction industry. The industry is expected to remain in this 'saturated' state for several years to come and AIQS is proactively assisting the profession in being able to meet the resourcing needs of contractors and firms by processing these assessments in an efficient and timely manner. As mentioned in my Treasurer's Report last year, the available additional funds are being channeled into new initiatives for the members such as establishing both the Diversity and Inclusion Committee and the Digital Innovation Committee. These committees will enable AIQS to assist members in dealing with these important issues over the coming years.

Finally, none of the above could have been achieved without the support of all of our members in assisting AIQS to promote the profession to a wider audience thereby increasing the profession's profile and to show the industry that AIQS members have the education, training and governance to provide fully independent cost advice.
