APPLICATION GUIDELINES

The Australian Institute of Quantity Surveyors (AIQS) is specified by the Department of Home Affairs as the relevant assessing authority for the occupation of Quantity Surveying ANZSCO 233213 only. Quantity Surveying is deemed to include: cost management, cost control, construction management, construction economics and cost engineering.

The AIQS also provides a "Qualifications Only" assessment of Australian qualifications which have been accredited by the AIQS. This option may be used for the purposes of Skilled Migration, however, the Assessing Authorities Quality Assurance (AAQA) functioning through the Department of Education, Skills and Employment (DESE), requires that applications for Skilled Migration are to be based on a combination of an applicant's qualifications and work experience.

APPLICATION REQUIREMENTS

All applications must include payment of the relevant Assessment Fee. This fee is non-refundable, regardless of the outcome of the assessment.

*Certified copy is a copy of an original document which is certified as a true copy by an authorised person. Authorised people include: Justices of the Peace (JP's) and legal practitioners. Certification must meet the current standards as set out by the Department of Home Affairs. Please refer to the Department of Home Affairs website. If your qualifications are not in English, you must provide certified copies of both the original language document and an English translation carried out by an authorised translator. Certification must appear on the front of the document (not the back page).

To manage identity fraud, we require copies of at least three of the following documents;

- *3.* Where possible, an Australian visa (supported by a foreign passport, which is needed for verification) OR ImmiCard
- 4. At least one other official photo bearing document

TIMEFRAME FOR ASSESSMENT

It may take up to two months after receiving all required documents to complete an assessment.

Please refrain from making contact with the AIQS during the assessment phase, as this can cause delays with processing your assessment.
